## **Eurasian Natural Resources Corporation PLC**

### **Successful Completion of Alumina Expansion Project in Kazakhstan**

London – Eurasian Natural Resources Corporation PLC ('ENRC' or, together with its subsidiaries, the 'Group') today announces that its Alumina and Aluminium Division has completed the expansion of its alumina refinery in Kazakhstan, Aluminium of Kazakhstan ('AOK'). The refinery has successfully reached its target alumina production level of 1.7 million tonnes per annum.

Investment into alumina expansion has been one of the key initiatives of ENRC's Alumina and Aluminium Division and has been completed on time and within its budgeted capital expenditure of US\$305m.

The larger alumina production capacity will support the Group's expanded aluminium production capacity. Importantly, this will also enable ENRC to maintain sales to third party customers and provide sufficient alumina for internal consumption.

The expansion of AOK comprises part of ENRC's on-going significant investment programme in Kazakhstan and Africa.

Felix J Vulis, CEO of ENRC, commented: *"I am delighted to announce completion of this important expansion project in Kazakhstan. We are now able to increase both our internal consumption and external sales of alumina, underpinning ENRC's ability to maintain competitive advantage as a low-cost producer."*

## **About ENRC**

ENRC is a leading diversified natural resources group, performing integrated mining, processing, energy, logistics and marketing operations. The operations comprise: the mining and processing of chrome, manganese and iron ore; the smelting of ferroalloys; the production of iron ore concentrate and pellet; the mining and processing of bauxite for the extraction of alumina and the production of aluminium; the production of copper and cobalt; coal extraction and electricity generation; and the transportation and sales of the Group's products. The Group's production assets are largely located in the Republic of Kazakhstan; other assets, notably the Other Non-ferrous Division, are mainly located in Africa; the Group also has iron ore assets in Brazil. The Group's entities in 2010 employed on average 74,098 (2009: 70,322) people. In 2010, the Group accounted for approximately 4% of Kazakhstan's GDP. The Group currently sells the majority of its products to Russia, China, Japan, Western Europe and the United States. For the year ended 31 December 2010, the Group had revenue of US\$6,605 million (2009: US\$3,831 million) and profit attributable to equity shareholders of the Group of US\$2,185 million (2009: US\$1,045 million). ENRC has six operating Divisions: Ferroalloys, Iron Ore, Alumina and Aluminium, Other Non-ferrous, Energy and Logistics. ENRC is a UK company with its registered office in London. ENRC's shares are quoted on the London Stock Exchange ('LSE') and the Kazakhstan Stock Exchange ('KASE').
